In anticipation of your visit to The St. George Inn we ask that you read and understand this Guest Registration Agreement, provide all requested information in the spaces provided below, including your signature, and return this Guest Registration Agreement to Anchor **within 14 days of the Reservation Date** listed below. Use of the word "Guest" in this Guest Registration Agreement refers to the guest listed below. Please return the completed Guest Registration Agreement to: Anchor Vacations, LLC, 101 East Gulf Beach Drive, St. George Island FL, 32328. Please note all reservation made online thru our website www.vacationsbyanchor.com have automatically agreed to the Guest Registration Agreement at the time of booking.

- A. Damaged/Missing Items:** Guest accepts financial responsibility for any items damaged or missing due to negligence or action on Guest's part. Guest hereby authorizes Anchor to charge the below listed credit card account for all reasonable repair or replacement cost of missing or damaged items, including missing keys.
- B. Cancellation Policy/Early Departures:** Guest shall receive a full refund less a \$25.00 processing fee if the below reservation is cancelled prior to 48 hours before the below arrival date. Guest shall not be eligible for any refund if the below reservation is cancelled within 48 hours of the below arrival date. No refund shall be given in the event Guest departs prior to the below departure date. No refunds shall be given due to weather and any other unforeseen issues. You may purchase travel insurance from Anchor Vacations, LLC to cover any unforeseen issues at the time of booking and only at the time of booking. *Please note payment is due in full upon booking at the St. George Inn.*
- C. Swimming Pool:** Guest acknowledges that Anchor nor any individual or entity holding an ownership interest in The St. George Inn shall bear no liability or responsibility for injuries or damages resulting from Guest's use of The St. George Inn swimming pool. Guest agrees to abide by all posted swimming pool rules including, but not limited to, no jumping or diving into the pool, running in pool area, and properly supervising children in the pool area.
- D. Smoking:** Absolutely **NO SMOKING** is allowed in any part of The St. George Inn. Any indication of smoking within The St. George Inn may result in offending guest being charged a fee to cover any applicable resulting charges including, but not limited to, dry cleaning, carpet cleaning and upholstery cleaning. Smoking is permitted on the outer decks. Please use the available cigarette disposables available on the decks.
- E. Pets:** Absolutely **NO PETS** are allowed at The St. George Inn. Any indication of a pet within The St. George Inn may result in offending guest being charged a fee to cover any applicable resulting charges including, but not limited to, dry cleaning, carpet cleaning and upholstery cleaning.
- F. Check-In/Check-Out:** Check-in is 4:00p.m. EST. Check-out is 10:00a.m. EST.
- G. Occupancy/Guest Conduct:** Occupancy for each suite at The St. George Inn is limited to no more than the maximum number of occupants as determined by Anchor in its sole discretion. In the event this is Guest's does not adhere to the limit per room, Guest's reservation will be terminated immediately and Guest will be required to vacate The St. George Inn. In the event Guest's conduct negatively affects other guests or is deemed to be detrimental to The St. George Inn or public safety, Guest's reservation will be terminated immediately and Guest will be required to vacate The St. George Inn.
- H. Lost Keys:** Guest will be charged a fee of \$35.00 in the event all sets of keys issued to Guest are not returned to Anchor.
- I. Housekeeping:** Our Innkeeper will not service rooms if the "do not disturb" sign is on or if the security lock is locked. There will be a service for the room daily.
